Construction Update-

- Marty Monette and I have researched installing and staffing metal detectors. The desired metal detectors cost approximately \$3,300 (40% discount for schools). The real cost is in staffing each device. According to CCSD, Horry County is the only district they know of that uses metals detectors every day in their secondary schools. They do not search every student every day. According to the Principal St. James High School (1,650 students), they randomly search students every day. The random selection changes each day. On occasion, they will search every student.

- Garrett Metal Detectors- safety assessment and proposal. They recommend 3 to 5 members per metal detector.
- New Position- Safety Officer (Classified Administrator)

A dedicated to position for school safety. This would be an armed, ex-police officer that would be in charge of campus safety and security. This person would take over all aspects of school safety: training of staff and

students, infrastructure needs, revision of all safety procedures and protocols, and supervision. This position exists at Charleston Charter School for Math and Science.
