Pricing Includes:

Base Bid

- a) Install & remove protection for turf & base access;
- b) Furnish, install, maintain & remove soil erosion;
- c) Excavation, load & dispose on-site spoils up to 4" of the existing profile;
- d) Relocate existing ball netting system to the outside edge of new turf area;
- e) Replace existing netting for lacrosse;
- f) Grade & compact existing sub-grade;
- g) Furnish & install 1,438 LF of 6"x12" perimeter concrete curb;
- h) Furnish & install a 2"x4" wood nailer board system to perimeter concrete curb;
- Furnish & install a 4 oz geo-fabric on the existing sub-grade;
- j) Furnish & install a 12" diameter HDPE perforated collector pipe in the turf area;
- k) Furnish up to 150 LF of a 12" dia. drainage pipe with outflow at the existing tidal creek area;
- l) Furnish & install 1"x12" perforated flat drains at 25' on center, turned into collector pipe trench;
- m) Furnish, install & grade a 5" profile of drainage base stone;
- n) Furnish, install & grade a 1" profile of finishing stone;
- o) Laser grade finishing stone to turf tolerances;
- p) Supply & install the artificial in-filled grass surface provided by Sprinturf as specified;
- q) Furnish & install 3.4 lbs/sf of ambient SBR crumb rubber infill & 1.3 lbs/sf of silica sand infill as specified;
- r) Furnish & assemble one (1) each LitterKat sweeper & 920SDE groomer by GreensGroomer;
- s) Provide an 8 Year manufacturer warranty;
- t) Provide (1) Gmax test at substantial completion.

Alternate Bid #1 (Allowance)

- a) Add to Base Bid;
- b) Provide engineering, construction drawings, soil borings, surveying & designing.

Alternate Bid #2

- a) Add to Base Bid;
- b) Provide one (1) SprintCare Maintenance visit per year for the life of the warranty.

Alternate Bid #3

- a) Add to Base Bid;
- b) Add Coolfiber turf cooling technology to proposed synthetic turf system;
- c) Furnish & install 1.0 lb/sf of Corkonut organic infill by GreenPlay as top layer of proposed infill system with 1.5 lbs/sf of ambient rubber and 2.8 lbs/sf of silica sand infill in lieu of base bid infill system.

























Notes:

- a) Any alteration or deviation from specifications involving extra costs is not included;
- b) This proposal does not include site security, permits, bid bonds, payment & performance bonds, engineered drawings, licensed surveying, protection of access points and staging areas provided;
- c) This proposal does not include unforeseen conditions, unsuitable soils, hazardous materials and/or waste, organics, solid rock/concrete, undercutting, utility relocation, fencing, electrical work, testing, seeding/sodding, watering and/or lawn maintenance of disturbed areas and grading/seeding/mulching of spoils area;
- d) Pricing assumes Sprinturf will be using standard construction equipment, given proper staging area and work area access;

Conditions

Notwithstanding any other document or agreement entered into by Sprinturf in connection with the supply and installation only of its product pursuant to the present bid proposal, the following shall apply:

- 1. This bid proposal and its acceptance is subject to strikes, accidents, acts of god and force majeure;
- 2. Sprinturf requires a minimum of 15 days after receiving final approvals on shop drawings to manufacture and deliver turf;
- 3. This proposal is based on a single mobilization. If additional mobilizations are necessary, additional charges will apply;
- **4.** Final Payment shall be upon the substantial completion of Sprinturf obligations. Sprinturf is entitled to cost recovery associated with collecting delinquent receivables;
- 5. Accounts overdue beyond 30 days of invoice date will be charged at an interest rate of 2% per month;
- 6. Sprinturf shall be accountable for its negligence but shall not be bound by any penalty clauses.
